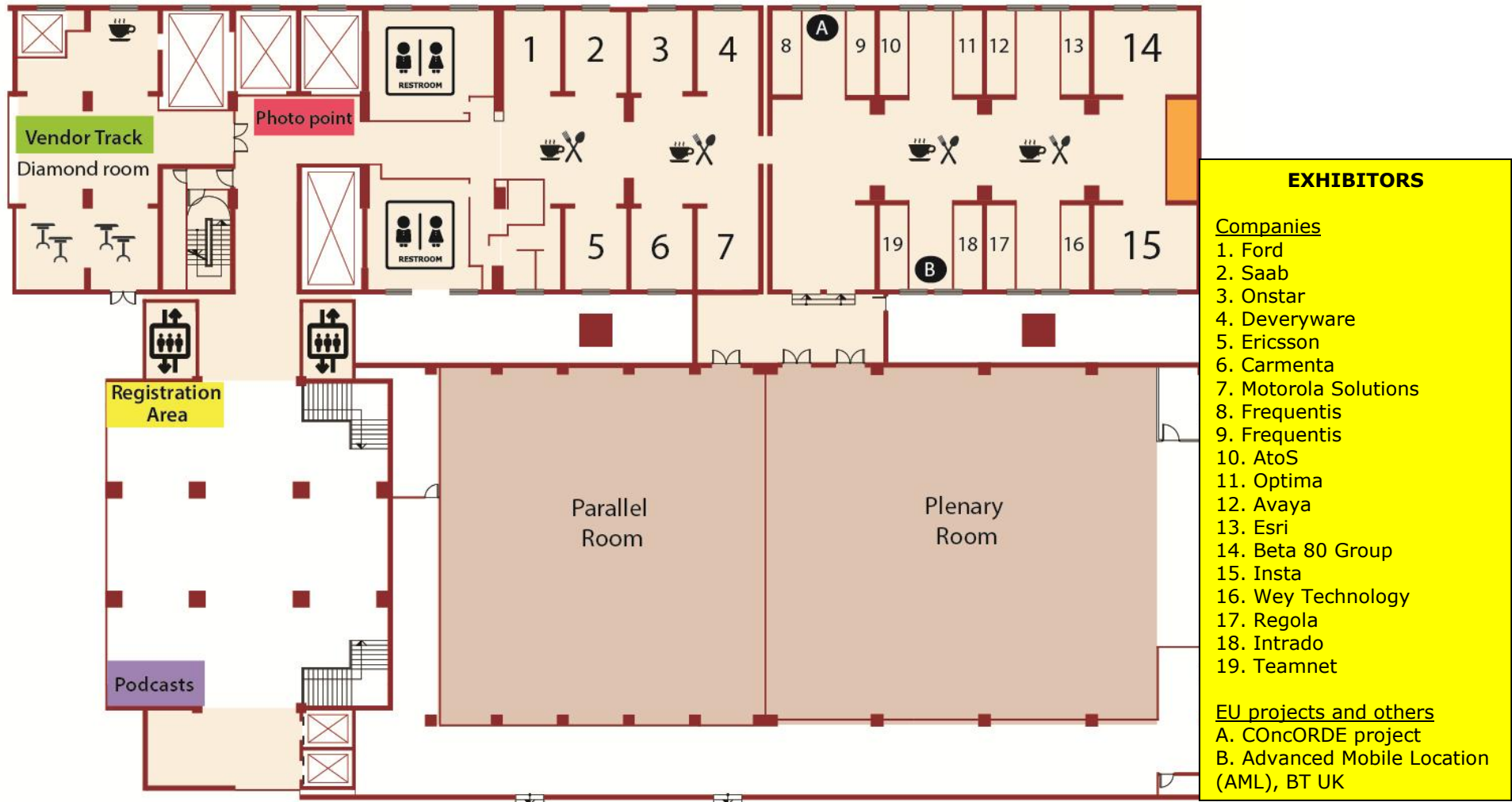
## ABOUT EENA
